



BUYER AGREEMENT FOR INSTALLATION OF A GPS SYSTEM

"I", "me", "my", "You", and "Your" means each Buyer identified below, jointly and severally. I am buying the below- referenced vehicle (the "Vehicle") from the dealer identified below (the "Dealer") pursuant to the Retail Installment Contract signed by me (the "Contract"), where said Contract is dated the same date as this Buyer Agreement for Installment of a GPS System (this "Agreement").

I agree as follows:

- A) I understand that the Dealer has installed a GPS System (the "GPS"). The GPS is a tracking system that allows the Dealer or any entity that purchases the Contract from the Dealer to locate the Vehicle in the event of default or theft. The most typical reason for default is failure to pay any amount due under the Contract when it is due.
- B) In the event of theft, location information will be released to law enforcement agencies through proper legal request.
- C) I understand that I do not own the GPS until I pay my Contract in full. I understand that the cost of the GPS, as well as the cost of installation, was not directly or indirectly charged to me. **TAMPERING WITH THE GPS UNIT IS A VIOLATION OF THE CONTRACT.**
- D) I understand and agree that once I pay off my Contract in full, I am the owner of the GPS and that neither the Dealer nor Southern Cascades Finance Corporation will access the GPS thereafter. I also understand and agree that after I am the owner of the Device and the GPS I must contract with Gold Star to use the GPS as a theft control product, for roadside assistance, or to use any other services provided by Gold Star at my option.
- E) If I do not want the GPS to remain with the Vehicle after I have paid off my Contract in full, and the GPS will be removed from the Vehicle at no charge to me. I understand that I must make the Vehicle available to the Dealer for the removal of the GPS and no refund will be due.

Do not sign this Agreement before reading it. By signing below, I acknowledge and agree that I have read the Agreement, completely understand the terms of the Agreement, and agree to all of its terms.

YOU MAY RECEIVE A PHONE CALL ON BEHALF OF SOUTHERN CASCADES BY A THIRD-PARTY GPS INSTALL COMPANY TO SET UP AN APPOINTMENT FOR GPS INSTALLATION

I understand that I may receive a phone call for the scheduling of a GPS install appointment from a third party on behalf of Southern Cascades. Failure complete this appointment could result in the delay of funding.
